1. Call to Order

6. Approval of the Minutes of Past Meetings

8. Updates

- **a. Regional Housing Plan:** The town-specific 8-30j plans are now in the process of being adopted. So far Middletown, Lyme and Portland have been adopted. After this process, the regional recommendations will move forward. We are hoping to have the regional portion of the plan posted for comment in June or July.
 - Mr. Neale stated that he is on the board of HOPE Partnership and asked that HOPE be designated as the regional advocacy organization as foreseen in the regional portion of the plan. He requested that HOPE do a short presentation at a future meeting.
- **b.** Comprehensive Economic Development Strategy (CEDS): The consultants are in the analysis phase now. We are finalizing membership in the strategy committee. An informational website will be published shortly and region-wide public engagement will begin in September.
- c. ALT to Farmington Canal Connector Project: Mr. Gold was not available to give this update.
- **d. Legislative:** Mr. Lovejoy highlighted some items in and answered questions about legislative items contained in the comprehensive written update he distributed.

9. Miscellaneous: State, Regional and/or Local Planning Issues

Chairman DeFelice noted that Durham is still examining their cannabis regulations. There has not been much public comment yet.

Mr. Demetriades reported that Cromwell closed their public hearing on cannabis and are finalizing regulations on medical, retail, and cultivation.

Ms. Stone reported that Lyme passed a cannabis ban on growing and selling.
