1. Call to Order, Roll Call, Introductions

Mr. Haramut reported that a US bike route may be designated on the shoreline area through Old Lyme, Old Saybrook, Westbrook and Clinton for the purpose of economic development. The route will be on Route 1, there is not creation of an additional trail. This is initiated by SECOG, the trail will run Providence to New Haven.

a. Aquatic Invasive Species Program Update

Ms. Burns reported that the public meeting for hydrilla, held at Middletown City Hall, was well-attended. River flooding hampered their schedule a bit. A dye study will begin by Aug. 7th, so if affected towns get calls from residents about red water, that is why. Notifications will be sent to the towns shortly.

The water chestnut program is underway. They are out on the water now. Three part-time staff have been hired to help pull.
