Call To Order

The meeting was called to order by Mr. Fogliano at 2:03 p.m. The meeting was held in person and via Zoom video conference.

Approval of Minutes of January 23, 2024 Meeting

Ms. Bandzes moved to approve the minutes of the January 23, 2024 meeting; second by Mr. Lahm. Vote was unanimous in favor.

Speaker – Beth Sabilia, Center for Housing Equity & Opportunity (CHEO), Eastern CT

Ms. Sabilia gave an overview of CHEO, which is one of three CHEOs in the state. She focuses on local advocacy in her role; there are multiple partners in CHEO that focus on other pieces of the pie, for example, The Partnership for Strong Communities focuses on legislation. There are three working groups within CHEO: narrative change, preservation and protection, and capacity building and production.

This year, they recently released a narrative change playbook on how to talk about housing in Eastern CT. They have also developed a score card to compare municipal housing plans with the CT DOH guidelines set forth for them (not how the plans are actually working in the field).

They may be able to help the RHC scale up our toolkit and share it with a wider audience.
