Mr. Rosengren discussed the Bokum Corner district plan that is currently in public hearing until May. Though Essex residents agree that affordable housing is needed, they do not agree to put it where it's been proposed.

Mr. Lahm mentioned that Lyme was working on a zoning regulation to allow for multi-family for affordable housing. This was put on hold because the POCD states that there cannot be multi-family. The POCD is due for its update.

Ms. Bandzes reported that the Chester affordable development is delayed and is now going through housing court.
